2020 Remote Student Program: Conditions of Participation Form**

I am a Harvard College undergraduate student, and I have chosen to participate in the David Rockefeller Center for Latin American Studies (DRCLAS) **Remote Summer Program (RSP)**, taking place **June 15 – August 7, 2020**. As a condition of participating in the DRCLAS RSP I agree to the following:

1. **Standards of Conduct:** I recognize that I assume an important obligation to conduct myself in a manner compatible with local laws and regulations, and with Harvard University's rules for student conduct. In addition, I agree to comply with all rules and norms set forth by DRCLAS, including those that I receive during orientation meetings. I agree that DRCLAS staff has the right to enforce its rules and regulations, and understand that if I violate any, I may be subject to disciplinary action within DRCLAS and/or at The University.

Regarding required disciplinary action during the RSP, I am aware that:

- I. I will not receive a refund for the program's confirmation deposit
 - II. I will be responsible for refunding my stipend, prorated to the date of my dismissal
 - III. Harvard Resident and Faculty Deans, as well as the University's various Administrative Boards, will be notified regarding behavioral issues
 - IV. Infractions may cause suspension, dismissal, and/or exclusion from any future programs and/or student funding opportunities led by DRCLAS
2. **Program Rules & Norms:** In addition to University-wide rules, I agree to comply with all rules and norms set forth by DRCLAS, including those that I receive during DRCLAS orientation meetings. I understand these may be distinct from University rules, and may reflect norms responsive to the current global context.

In particular, I am aware that during the Remote Summer Program:

- a. I must attend and engage in all programmatic activities organized by the DRCLAS staff, including, but not limited to, scheduled check-ins, cultural activities, and all professional enrichment work hours;
- b. If I miss **two or more** events, sessions, or related commitments without permission, I will be removed from the Program, and will confront the disciplinary actions detailed above in Section 1.
- c. I must acknowledge and respect the host organization's primary language, standards of work, and overall norms, as detailed by my supervisor(s); and
- d. I will participate fully in all program components, and will refrain from conduct that is improper, offensive, or otherwise inappropriate for the Program, collaborators, and/or others participants' health and wellbeing. I agree to be familiar with and obey all of the rules established for the RSP, including the **Standards of Conduct in the Harvard Community**.
